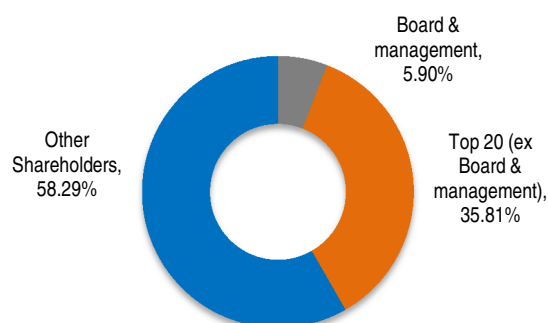


CORPORATE UPDATE

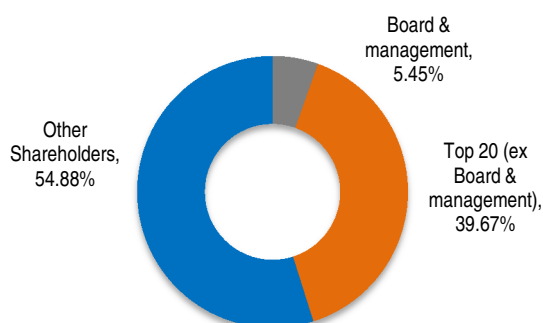
Collaborate Corporation Limited (ASX:CL8) is pleased to provide the following update on its security holder register. Key highlights include:

- + 57% of CL8O Options held by the Board & management and top 20 holders (up from 53% at 30 September 2015).

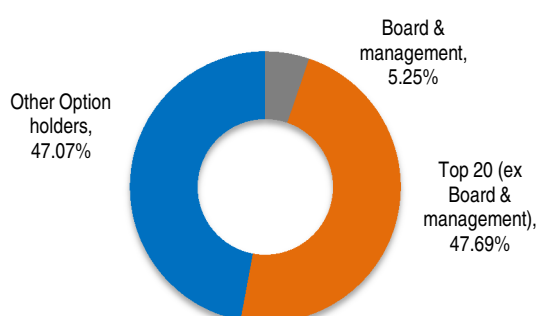
Shareholding breakdown
(as at 30 September 2015)



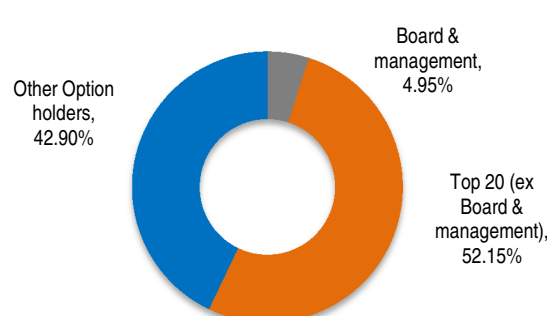
Shareholding breakdown

Upon completion, this subscription will increase the Share and Option holdings of Board & Management to 6.06% and 5.40%, respectively.
