

ISSUED CAPITAL AND TOP 20 SHAREHOLDER UPDATE

Collaborate Corporation Limited (ASX:CL8) (**Collaborate** or the **Company**) is pleased to confirm that it has completed the conversion of CL8O options with an exercise price of \$0.02 per option and an expiry date of 30 April 2017 (**CL8O Options**). A total of 175,014,728 CL8O Options were exercised to raise \$3,500,295, including 2,925,244 options exercised on 2 September 2015 which raised \$58,504.

Following conversion of all of the CL8O options, 619,117,857 fully paid ordinary shares (**CL8 Shares**) are now on issue. 47.79% of the shares are held by the Top 20 shareholders.
